Respecting the rights and freedom of the persons whose data we process and fulfilling our obligation under Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (further "GDPR"), we provide the following information:

WHO IS THE CONTROLLER OF YOUR PERSONAL DATA

The personal data controller is home&you S.A. (NIP 584-20-56-682), registered office in Gdańsk at ul. Juliusza Słowackiego 224, hereinafter referred to: "Controller" or "We".

Art. 6(1)(f) GDPR	Until an objection is raised by the person.
Infringement notification and follow-up.	Personal details of the whistleblower disclosed in the submitted notification.	Article 6(1)(c) of the GDPR in relation to Chapter III of the Act of 14 June 2024 on the protection of whistleblowers.	3 years from the end of the calendar year in which the follow-up action was completed or after the end of the proceedings initiated by the follow-up action.

WHO CAN ACCESS PERSONAL DATA

Personal data may be disclosed to public authorities to the extent and for the purposes that follow from the provisions of the applicable law, as well as to any entities that process the personal data pursuant to relevant agreements signed with the Controller i.e.: providers supporting the website service:

- analytical services providers (Google Analytics)
- hosting providers
- website administration services providers.

The whistleblower's personal data will only be disclosed to persons designated and authorised by the Controller on the basis of power of attorney to receive information on infringements of the law and to take follow-up action.

DOES THE CONTROLLER TRANSFERS PERSONAL DATA TO THIRD COUNTRIES

The controller does not transfer personal data to third countries or international organisations.

WHAT ARE THE RIGHTS OF THE PERSON WHOSE PERSONAL DATA WE PROCESS

You have the right to request any of the following at any time:

1. access the data to the extent set out by the provisions of the GDPR (Article 15 GDPR),
2. correct the data (Article 16 GDPR),
3. erase the data when one of the grounds indicated by the GDPR is fulfilled (Article 17 GDPR),
4. limit/restrict processing of the data in all circumstances determined by GDPR (Article 18 GDPR),
5. transfer the data (Article 20 GDPR),
6. lodge a complaint to supervisory authority that is the President of the Personal Data Protection Office (Article 77 GDPR).
7. to object if the data are processed for legitimate purposes pursued by the Controller (Article 21 GDPR)

IS DISCLOSING OF PERSONAL DATA MANDATORY

Disclosing of personal data is voluntary.

DO WE APPLY PROFILING AND AUTOMATIC PROCESSING OF PERSONAL DATA

While processing the personal data of website users we do not use profiling nor adopting automatic decision.

COOKIES

We only use cookies that are necessary or support the functionality of the website (the design and content changing, fonts presentation, graphic elements and other website settings, saving the user's decision to install cookies on the device). We do not install cookies that collect data for marketing purposes via our website."
